### How to get to Ghaziabad

Ghaziabad is a part of India's National Capital Region. The best way to reach Ghaziabad is via Delhi. The town is located at a distance of 45 kilometers from the Indira Gandhi International Airport and 30 KMs from New Delhi railway station. It is well served by road and rail links. Delhi is well-connected through rail and air to all corners of India and the world. The institute can arrange for airport pickup on request. Pre-paid taxi service is available from international/ domestic airports for Ghaziabad. The prepaid taxis for Ghaziabad are distinct from the routine prepaid taxis for commuting within New Delhi. You may also requisition Radio Taxi service after reaching the airport. ### Accommodation
